



# **SOCIAL VALUE SPOTLIGHT**



When we say 'not-for-profit', we mean it! Frameworx is committed to investing our surplus into social value initiatives, research and training that delivers tangible benefits to the community.

Since we started, we have donated our surplus to charities in the sector, including the Peabody Foundation and Clive Smith Foundation. At the NHMF Conference in January, we made our biggest contribution to date.

We invited Approved Providers to nominate one of the clients they are working with via Frameworx to receive a donation from our new Social Value Fund. Each of the three providers involved match funded this donation, so we were collectively able to donate £3,000 during the conference to support social value projects in the Frameworx community.



Contracts called off by Direct Award must be awarded in accordance with "objective criteria", which this \*simplified flow chart can help you with. (\*refer to the full flow chart in the Frameworx brochure.)

It is important that Clients follow this process exactly, otherwise their call-off may be open to challenge.
